### Message from the President

Dear Residents and Friends,

Since the April 2013 floods, the Village has been working on alleviating storm water issues around town. Unfortunately, the Village and region have seen three "50 year floods" (defined as a 2% chance of happening in any given year) in the last ten years. We can assume we will be seeing more severe weather in the future.

There is no one storm water solution, and much of the low hanging fruit has been picked. Nevertheless, we continue to look for ways to address the problem. The Village has been working to alleviate problems in many areas and in others, is making efforts to prevent problems from getting worse. Trustees, Village staff, and the Village engineer have met with many residents affected by storm water and have been working on storm water solutions on an individual or neighborhood level. Sometimes all it takes is re-ditching or regrading to improve a storm water flow. The Village has not been working alone. The Park District is working on major improvements to Hosek Park which includes the ability to hold more water. These improvements could result in real flood reduction in the surrounding area.

On a policy level, storm water management is now a priority for all public and private improvements within the Village. For public projects, we design all improvements, including roadways, any new parking lots, and ditches to handle more water than before. New projects are engineered to more effectively move the water. For example, you may have seen culverts being replaced as part of the 2015 Road Program. Additionally, all upcoming proposed projects, like the commuter improvements to the Metra station area, include new storm water capacity built into existing areas.

All private development will be expected to hold their own share of run-off. Since January 1<sup>st</sup>, 2015, all new residential improvements over 300 square feet of new impervious area are required by ordinance to store all newly created storm water run-off onsite. So, a new/remodeled house under construction will be required to include storm water storage onsite. These restrictions already impacted most commercial projects, but additionally the Village goes above these requirements in negotiations with developers to try to get the projects to store even more water.

Unfortunately, our local government will not be able to do it alone without massive costs. At last estimate, every major identified storm water improvement to be addressed in Clarendon Hills would exceed \$8 million dollars a piece for a total in excess of \$38 million (these projects are detailed at [clarendonhills.us/stormwater.cfm](http://clarendonhills.us/stormwater.cfm)). These improvements are not affordable and the benefits would only affect a limited area.

However, there are improvements every resident could make to their properties to help their neighbors. With the help of a local Eagle Scout, the Village recently ran a campaign to raise awareness for rain barrels. Not only do rain barrels reduce storm water issues, they also can save you money on your water bill. It may seem silly given the extent of some rain events, but on a day-to-day basis a lot of minor storm water issues can be reduced if everyone chips in a little. At the next step up, rain gardens can provide a beautiful way to hold a lot more water. I am calling on everyone to show a little neighborly spirit and commit to at least a rain barrel to help their neighbors.

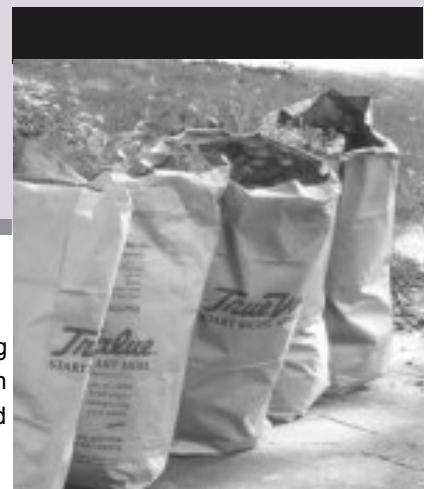
## **Compost Your Pumpkins with SCARCE!**

## Winter Parking Reminder



Residents are required to park off the Village streets if the weather predicts 2 or more inches of snow fall to allow for proper snow removal. Also note that no person shall dump snow onto any public road, public sidewalk or fire hydrant.

## 2016 Road Construction

In 2016 the focus for road construction will be on the south area streets. Construction is scheduled to start June 2016 with the following streets:

- 56th
- Colfax
- Harris (Western – Walker)
- Hudson (Richmond – Western)
- Richmond (55th – Park)
- Ridge (Richmond – Western)
- Ruby (Richmond – Walker)
- Western (56th – Park)



This represents an additional 3.03 miles of streets to be upgraded to the Village's concrete shoulder standard. It encompasses the majority of the roads which were last resurfaced as part of the 1999 SSA with four segments dating back to the 1995 SSA.

This project will require coordination with the Village of Westmont, which has begun, since they have jurisdiction over ½ of Richmond. We will be replacing water main ahead of the road work on Ruby and Colfax, with the possibility of additional segments on Richmond and Western.

Residents in these areas will be in continuous contact with the Village throughout the process.

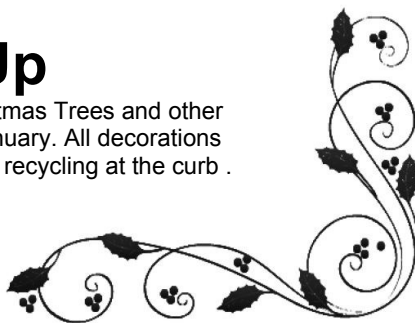
